1. Minutes of Previous Assembly:

The minutes of the previous Assembly of Principals and Electors of the Parish of St Brelade held on 18 February 2020, were adopted, and signed following a proposition by Mr Peter Norman, which was seconded by Centenier Michel Bougeard.

2. Appointment of Deputy Registrar:

The appointment of Mr Mark Le Boutillier as Deputy Registrar was notified to the Assembly and approved.

3. Election of Officier du Connétable:

The Connétable called for nominations to fill two positions of Officier du Connétable for the Vingtaine de la Moye for a term of three years.

Centenier Bougeard proposed Mr Mark Pilbeam for election. This nomination was seconded by Mrs Susan Bougeard.

A further nomination was received by Mr Norman proposing Mrs Susan Bougeard for election. This nomination was seconded by Mr Arthur Morley.

The Connétable congratulated and declared Mr Pilbeam and Mrs Bougeard duly elected as an Officiers du Connétable for a three-year term. Their date to appear before the Royal Court of Jersey to be administered the Oath of Office was set for Friday 3 April 2020.

4. Election of Officier du Connétable:

The Connétable called for nominations to fill the position of Officier du Connétable for the Vingtaine des Quennevais for a term of three years.

Centenier Bougeard proposed Mr Malcolm Tucker for election. This nomination was seconded by Mr Norman.

The Connétable congratulated and declared Mr Tucker duly elected as an Officier du Connétable for a three-year term. His date to appear before the Royal Court of Jersey to be administered the Oath of Office was set for Friday 3 April 2020.

5. **Election of Officier du Connétable:** The Connétable called for nominations to fill the position of Officier du Connétable for the Vingtaine de Noirmont for a term of three years.
- Centenier Bougeard proposed Mr Michel Feger for election. This nomination was seconded by Mr Morley.

The Connétable congratulated and declared Mr Feger duly elected as an Officier du Connétable for a three-year term. His date to appear before the Royal Court of Jersey to be administered the Oath of Office was set for Friday 3 April 2020.

6. **Election of Vingtenier:** The Connétable called for nominations to fill the position of Vingtenier for the Vingtaine des Quennevais for a term of three years.
- Centenier Bougeard proposed Mr Ewan Haywood for re-election. This nomination was seconded by Mr Morley.

The Connétable congratulated and declared Mr Haywood duly re-elected as Vingtenier for a three-year term. His date to appear before the Royal Court of Jersey to be administered the Oath of Office was to be confirmed.

7. **Election of Vingtenier:** The Connétable called for nominations to fill the position of Vingtenier for the Vingtaine du Coin for a term of three years.
- Centenier Bougeard proposed Miss Anna Kielak for re-election. This nomination was seconded by Mrs Bougeard.

The Connétable congratulated and declared Miss Kielak duly re-elected as Vingtenier for a three-year term. Her date to appear before the Royal Court of Jersey to be administered the Oath of Office was to be confirmed.
