PARISH ASSEMBLY

Minutes of an Assembly of Principals and Electors of the Parish of St Brelade held at the Parish Hall, St Brelade on Tuesday 30 June 2020 commencing at 19:00 hours

President of Assembly:

Connétable Mr Michael Keith Jackson, presided

Convening Notice:

The Convening Notice was read by the Parish Secretary

1. Minutes of Previous Assembly:

The minutes of the previous Assembly of Principals and Electors of the Parish of St Brelade held on 26 May 2020, were adopted, and signed following a proposition by Mr Peter Norman, which was seconded by Centenier Michel Bougeard.

2. <u>Election of</u> <u>Officier du</u> Connétable:

The Connétable called for nominations to fill the position of Officier du Connétable for the Vingtaine des Quennevais for a term of three years.

Centenier Amanda Wright proposed Miss Leena Varkey for election. This nomination was seconded by Mr Ian Wright.

The Connétable congratulated and declared Miss Varkey duly elected as an Officier du Connétable for a three-year term. Her date to appear before the Royal Court of Jersey to be administered the Oath of Office was set for Friday 10 July 2020.

3. <u>Election of Vingtenier:</u>

The Connétable called for nominations to fill the position of Vingtenier for the Vingtaine de la Moye for a term of three years.

Centenier Wright proposed Mr Christopher Martin Jones for re-election. This nomination was seconded by Mr Wright.

The Connétable congratulated and declared Mr Jones duly re-elected as a Vingtenier for a three-year term. His date to appear before the Royal Court of Jersey to be administered the Oath of Office was set for Friday 10 July 2020.

4. Representat ion to Licensing Assembly:

The Connétable advised that Noya Shapla wished to apply to the Licensing Assembly for an extension to the area their current 3rd category licence covered, following a permit to extend their Chose Publique (al fresco) outside seating area. A plan of the area had been available to view on the Parish

website and on the online Gazette and is attached to and forms part of these minutes.

Mr Alan Breckon said a few words on behalf of the company. He advised that the restaurant had now been open for 3 years, they had a good inside area, takeaway and small outside area, however when Covid-19 hit hospitality was greatly impacted, once the restrictions started to ease restaurants were still required to keep people apart. Mr Breckon advised that Noya Shapla have been huge supporters of Health and Essential workers, providing them with free hot meals. The restaurant continue to offer their takeaway service and have survived only because of this. The proposition is to utilise the petanque area after 6pm, weather permitting, the pitch is not used at this time and is mostly used on Sundays, however the users have been consulted with and they had no objections. Mr Breckon further advised that the Miah family were long standing residents and supporters of St Aubin.

The Connétable then asked for any questions or comments.

There being no questions or comments the Representation was proposed to the Assembly by Mr Alan Breckon and was seconded by Mr Johirul Miah. Following a vote by a show of hands, the item was supported by 29 votes in favour and 0 votes against.

5. Licensing:

In accordance with Article 5 (1) of the Licensing (Jersey) Law, 1974, as amended, the following applications were considered for recommendation to the Licensing Assembly:

The Connétable advised that he had received satisfactory reports as required from Environmental Health, Jersey Fire and Rescue and an Architects report.

The Connétable then asked for a representative of the company to say a few words.

Mr John (Laing) Gilmour explained that the coffee shop had been around for 18 years keeping the village alive. Mr Custodio Gomes advised that the application was effectively just a change of the company and business name.

The Connétable then asked for any questions or comments.

Centenier Bougeard asked why the establishment required the 6th category off licence and was advised it was purely for those walk ins who wish to purchase a takeaway. It was not intended to provide a takeaway delivery service at the moment.

There being no further questions or comments, recommendation of the application to the Licensing Bench was proposed by Mr Gilmour and was seconded by Mrs Rosemary Gilmour. Following a vote by a show of hands, the item was supported by 25 votes in favour and 0 votes against.

In thanking the remaining 35 persons for their attendance, the Connétable declared the meeting closed at 19:15 hours.
