1. Minutes of Previous
Assembly:

The minutes of the previous Assembly of Principals and Electors of the Parish of St Brelade held on 14 July 2020, were adopted, and signed following a proposition by Deputy Graham Truscott, which was seconded by Mr Peter Durham Waite.

The Connétable advised that he had received satisfactory reports as required from Environmental Health, Jersey Fire and Rescue and an Architects report.

The Connétable then asked for a representative of the company to say a few words.

Mr David Pallot thanked the Connétable for holding the Assembly at such short notice. He explained that the restaurant will be known as Artemis Greek Taverne. Mr Pallot explained that Mr Tokkalos was born in Jersey and has been in the restaurant and catering business for 35 years, he has previously held liquor licenses before and his family have many year's experience owning Greek restaurants. The premises is primarily to serve Greek food accompanied by wine,

beer and Ouzo. Mr Pallot felt that the restaurant would be a welcome addition to St Aubin.

The Connétable then asked for any questions or comments.

Mr Tokkalos commented that there was previously a Greek restaurant in St Aubin next to the current premises called Le Petit Greek, the premises itself also used to be a Greek restaurant many more years ago. It is hoped to promote a casual dining experience with a nice atmosphere.

The Connétable reminded the Assembly that anyone who asks a question regarding the application is able to speak at Licensing Assembly, the date of which is to be confirmed.

There being no further questions or comments, recommendation of the application to the Licensing Bench was proposed by Mr David Pallot and was seconded by Mr Kevin James Metcalfe. Following a vote by a show of hands, the item was supported by 14 votes in favour and 0 votes against.

In thanking the remaining 17 persons for their attendance, the Connétable declared the meeting closed at 19:06 hours.
