Convening Notice:	The Convening Notice was read by Parish Secretary, Fee Roberts.
1. Minutes of previous Assembly	The Minutes of the meeting held on the 27 April were read. There were no matters arising. Mr Peter Norman proposed and Mr Arthur Morley seconded the Minutes and this received unanimous approval.
2. Elect one Officier du Connétable for the vingtaine de Noirmont	<p>The Chef de Police, Centenier Michel Bougeard proposed the re-election of John Holloway. Centenier Bougeard advised that Constable's Officer Holloway had given outstanding service to the Parish and had no hesitation in proposing him.</p> <p>Vingtenier Jane Drew in seconding the proposition reiterated Centenier Bougeard's words and added that Constable's Officer Holloway is conscientious and precise in his work and that he has assisted her greatly in her role with the Honorary Police.</p> <p>The Connétable thanked both Centenier Bougeard and Vingtenier Drew and asked the floor for a show of hands for all in favour. The nomination was approved by 13 votes with none against.</p> <p>Constable's Officer Holloway was declared duly elected and warned to attend the Royal Court on a date to be advised.</p>
3. Elect one Officier du Connétable for the Vingtaine de la Moye	<p>Nominations for an Officier du Connétable for the Vingtaine de la Moye.</p> <p>Mr Keith Syvret took to the floor to nominate Mrs Linzi Packer. He had known Mrs Packer for 5 years since she arrived on the Island with her husband and children. She was hard working in both her professional and personal life and would embrace Parish life with the Honorary Police.</p> <p>The Chef de Police, Centenier Michel Bougeard in seconding the proposal reiterated Mr Syvret's comments and that Mrs Packer would be a welcome new member into the Parish of St Brelade Honorary Police.</p> <p>The Connétable thanked both the proposer and seconder and asked for a show of hands of all those in favour. The nomination was approved by 13 votes to none.</p> <p>Mrs Packer was declared duly elected and wanted to attend the Royal Court at a later to be advised.</p>

	The Connétable congratulated and thanked both newly elected Constable's Officers for standing.
