The Chairman asked for a show of hands and with all those in favour, the Minutes were approved unanimously. |
| 2. <u>To consider an application for a Bailiff's Annual Entertainment Permit (P49) by Korina Powell (Secretary) in respect of "the Old Court House", Le Boulevard, St Aubin, holder of 1st and 3rd Category Liquor Licences:</u> | The Chairman advised those assembled that this item had been withdrawn from the proceedings by the Company, the Liberation Brewing Company. |
| 3. <u>To approve expenditure from the Property Reserve Fund not in excess of £15,000 for the refurbishment of the bathroom on Flat 1 of the Parish Hall:</u> | <p>The Chairman advised the meeting that the bathroom in Flat 1 needed total refurbishment. It had been some time since any changes had been made to it. Mr Johnathan Renouf asked if that sum was enough for what was being considered. The Chairman advised that the sum was more than sufficient to do the work. Mrs Enid Quenault, a previous Connétable of the Parish said that she thought that nothing had been done to the bathroom since the very late 90s. It was time to refurbish.</p> <p>The Chairman asked for a show of hands in favour of the proposition and the vote was carried unanimously.</p> |
