1. Minutes of Previous Assembly:	The Minutes of the previous Assembly of Principals and Electors of the Parish of St Brélade held on Tuesday 12 July 2022 were adopted after a proposal by Centenier Amanda Wright that the Minutes be taken as read and seconded by Officier du Connétable, Ian Wright.
2. Elect one Officier du Connétable for the Vingtaine du Coin	<p>The Connétable invited nominations for the post of Officier du Connétable for the Vingtaine du Coin.</p> <p>The Chef de Police, Michael Bougeard advised the Meeting that he wished to nominate Officier du Connétable Ross Turpin who had already been in the position for six years. The Chef de Police advised that CO Turpin was a very valued officer and indeed was their Training Officier.</p> <p>The Connétable asked if there was a seconder for the nomination and Vingtenier Jane Drew said she would echo all that the Chef de Police has already said. CO Turpin was very good with cars, was a committed officer and family man. 3. Elect one Officier du Connétable for the Vingtaine de la Moye	<p>The Connétable invited nominations for the post of Officier du Connétable for the Vingtaine de la Moye.</p> <p>The Chef de Police said he had no hesitation in nomination Officier du Connétable Ian Wright to serve another three-year term. CO Wright had a way of finding out of date WIDs and defects on cars. CO Wright is very thorough and works extremely hard.</p>
