## PARISH ASSEMBLY

Minutes of an Assembly of Principals and Electors of the Parish of St Brélade held in the Main Hall at the Parish Hall, St Aubin, St Brelade on Tuesday 25 October 2022 commencing at 19:00 hours.

Chairman of the Parish Assembly:	Procureur du Bien Public Peter Norman, presided.
Convening Notice:	The Convening Notice was read by the Assistant Parish Secretary.
1. Minutes of Previous Assembly:	The Minutes of the previous Assembly of Principals and Electors of the Parish of St Brélade held on Tuesday 25 October 2022 were adopted after a proposal by Arthur Morley that the Minutes be taken as read and that was seconded by Samantha Cox.
2. In accordance with Article 5(1) of the licensing (Jersey) law, 1974 as amended, consider the following licensing application for recommendation to the licensing Assembly.  Tres D'or Limited Mr Vasile Cosmin Popa 3rd (Restaurant0 category Tresor La Neuve Route St Brelade	The Chairman announced consideration was being given for a 3 <sup>rd</sup> (Restaurant) category licence for Tres D'or Limited (Previously Shinzo). Reports from Morris Architects stated that previously 70 Patrons had been allowed for internally and 24 externally and the report from the Environmental Dept supported that but was subject to the Report from the Fire Department which would confirm occupancy numbers which had not yet been received.  There being no legal representation for the Company Mr Popa spoke on behalf of Tres D'or Limited and said the restaurant would have a French style cuisine and was just a restaurant not a bar, with an outside area and quiet background music.
JE3 8BS	The Chairman advised the Assembly that he had received a copy of an e-mail sent from Jason Troy requesting that the applicant be questioned regarding whether the licence was to be extended to the outside patio area and if so whether there would be any time restrictions.  Mr Popa explained that the outside area was included in the occupancy numbers and a time restriction of 10pm for when music to be stopped by and the area would be
	vacated by 23:00 hrs was planned.  However the Chairman felt there was a lack of understanding of the exact requirements of the law and requested that Mr Popa seek advice From Mr Jason Troy regarding occupancy of all of the restaurant area.
