	Minutes of an Assembly of Principals and Electors of the Parish of St Brelade held at St Brelade's Parish Hall on Tuesday 23 May 2023 commencing at 19:00 hours.
President of Assembly:	Connétable Mr Michael Keith Jackson, presided.
Convening Notice:	The Convening Notice was read by the Acting Parish Secretary.
1. Minutes of Previous Assembly:	The Minutes of the previous Assembly of Principals and Electors of The Parish of St Brelade held on 28 April 2023, were adopted, and signed following a proposition by Mr Arthur Morley which was seconded by Mr Chris Cooke.
2. Election of Officier du Connétable Vingtaine des Quennevais:	<p>The Connétable called for nominations to fill the position of Officier du Connétable for the Vingtaine des Quennevais for a term of three years.</p> <p>Mr Robert Piechota was proposed by CO Ian Wright and seconded by Centenier Amanda Wright.</p> <p>CO Ian Wright stated that Robert worked on his team and worked very well. Centenier Amanda Wright stated that Robert was very popular, worked well in public and was delighted he was standing again.</p> <p>The Connétable asked if there were any more nominations. None were forthcoming.</p> <p>The Connétable congratulated and declared Mr Piechota duly elected as an Officier du Connétable for a three year term. He was advised to appear before the Royal Court of Jersey to be administred the Oath of Office at 10 am on 26 May 2023.</p>
3. Election of Officier du Connétable Vingtaine du Coin:	<p>The Connétable called for nominations to fill the position of Officier du Connétable for the Vingtaine des Quennevais for a term of three years.</p> <p>Centenier Raoul Gear proposed Miss Nevalda Vieira for election. This nomination was seconded by Centenier Michel Bougeard. Centenier Bougeard stated that Nevalda joined the Honorary Police during Covid and thanked her for standing again.</p>

Election of Vingtenier des Quennevais:</p>	<p>The Connétable called for nominations to fill the position of Vingtenier for the Vingtaine des Quennevais for a term of 3 years.</p> <p>Centenier Raoul Gear proposed Ewan Haywood for this position. he stated that Ewan was a valued member of the team and very reliable. Centenier Bougeard seconded this nomination.</p> <p>The Connétable asked if there were any more nominations. None were forthcoming.</p> <p>The Connétable congratulated and declared Mr Haywood duly elected as an Officier du Connétable for a three year term. He was advised to appear before the Royal Court of Jersey to be administered the Oath of Office at 10 am on 26 May 2023.</p>
<p>5. Gallery Café and Deli. Application for 3rd (Restaurant) & 6th (Off Licence) Category:</p>	<p>The application was proposed by Mr Nigel Robson and seconded by Mr Frank Walker who said the Gallery was an asset to St Aubin. Deputy Moz Scott supported the proposition but was concerned about litter and any litter emanating from the premises should be strictly controlled.</p> <p>The Connétable asked for a show of hands for all those in favour. There were 18 in favour and none against.</p> <p>The proposition was accepted.</p>
