The Assembly was held to proceed with the election of one Procureur du Bien Public, the term of office of Arthur Morley being due to expire by virtue of the provisions of Article 2 of the Procureurs du Bien (Terms of Office) (Jersey) Law 2013, the said 11 September 2024 being the next appointed day referred to in Article 2 of the said Law.

The Connétable called for nominations to fill the office of Procureur for the next three years.
