

Official Election Candidate Nomination Form

IMPORTANT INFORMATION FOR PROSPECTIVE CANDIDATES

- This nomination form relates to the Election of Senators, Connétables and Deputies to the States Assembly on Sunday 7 June 2026 only.
- You may submit one form only. You **cannot** stand for multiple roles in the election on Sunday 7 June 2026.
- You must complete the nomination form as directed. Any forms that are incomplete or incorrect will not be accepted. You will need to return with a correctly completed form.
- You must submit your nomination form **in person** to the JEA (administration to be undertaken by the States Greffe on behalf of the JEA) at Morier House, Halkett Place, St. Helier, JE1 1DD.
- Nomination forms can be submitted between 9am and 5pm on Monday 20, Tuesday 21 and Wednesday 22 April 2026. Submissions will **not be accepted** after 5pm on Wednesday 22 April 2026 under any circumstances.
- **Before submitting your nomination form**, you must also submit up to 450 words and a photograph for inclusion on your Vote.je page and the candidate booklet by email to contact@vote.je. If you do not submit any words or a photograph, your website and manifesto booklet pages will appear blank. Advice on the format of the words and the photograph will be provided separately.
- You will need to bring photographic identification that is in date (passport or driving licence) with you when you submit your nomination form.
- You should allow plenty of time when you come to submit your nomination form, as:
 - You will need to wait for your form and accompanying information to be checked.
 - There may be other candidates ahead of you in a queue.

INSTRUCTIONS FOR COMPLETING THE NOMINATION FORM

You must complete Part A and Part B before any other part of the form is completed.

**You must add your details in Part C on each page which will be signed by the proposer and 9 seconders.
Your proposer and 9 seconders should complete Part C only after you have completed Parts A & B.**

WHAT HAPPENS NEXT

- After submitting your nomination form, the JEA will send a copy of it to the electoral administrator of the constituency to which it relates or for Senatorial candidates to the Parish where you are resident and each Parish in which a proposer or seconder's address is located.
- The electoral administrator will review the form and notify the JEA of any issues with the form. Note that this review will include verification that:
 - the prospective candidate is on the electoral register;
 - any candidate for the role of Connétable (only) is resident in the Parish they wish to represent with the exception of St. Helier, where all rate payers are eligible and will be verified by the Parish;
 - the proposer and 9 seconders are on the electoral register of the constituency the candidate is standing for election in.

If candidates, proposers or seconders do not know their electoral number, the electoral administrator will insert the number on the form provided they are able to verify the individual on the electoral register.

- In the case of any defective forms, the JEA will notify the prospective candidate so that a new nomination form can be submitted.
- The JEA will use the contact details you have provided to confirm your candidacy and to alert you of any issues with your nomination form.
- The JEA will notify the prospective candidate that their nomination form has been accepted.
- All candidates will be announced to the public and media on Monday 27 April 2026.

Appendix 1 – Guidance on eligibility to stand for Connétable of St. Helier

In accordance with the [Parish of St. Helier \(Qualifications for Office\) \(Jersey\) Law 1976](#):

- a person liable to pay either the occupier's rate or the foncier rate (or both) on 1 January 2026 in respect of a property in St. Helier is eligible to be nominated to be Connétable of St. Helier; and
- a person who is the representative (*mandataire*) of a corporate person liable to pay either the occupier's rate or the foncier rate (or both) in respect of a property in St. Helier is eligible to be nominated to be Connétable of St. Helier.

In accordance with the data protection law, the Parish Secretary for St. Helier will confirm to the Jersey Electoral Authority (JEA) that the relevant person is on a rates list or the list of representatives.

If a corporate body were to change who its representative (*mandataire*) is, anyone who ceased to be the representative (*mandataire*) before the election would cease to be eligible. If this was found to be the case the Parish Secretary would have to notify the JEA.

Appendix 2 – Convictions that must be declared by election candidates

In accordance with Article 9 of the States of Jersey Law 2005 (for the role of Senator or Deputy) and in accordance with Article 4A of the Connétables (Jersey) Law 2008 (for the role of Connétable) candidates must declare –

- (a) any unspent convictions, whether in Jersey or elsewhere; **and**
- (b) any spent convictions, whether in Jersey or elsewhere, for the following offences –
 - treason;
 - murder;
 - manslaughter;
 - any offence that is a relevant offence within the meaning of the Sex Offenders (Jersey) Law 2010;
 - any offence committed when the person seeking election was of full age, against another person who was not, at the time of the offence, of full age;
 - fraud or any like offence;
 - obtaining property by false pretences;
 - theft;
 - perjury;
 - perverting the course of justice;
 - an offence mentioned in the definition “drug trafficking” in Article 1(1) of the Misuse of Drugs (Jersey) Law 1978;
 - an offence of attempt to commit any of the aforementioned offences;
 - an offence of conspiracy or incitement to commit any of the aforementioned offences;
 - an offence of aiding, abetting, counselling or procuring any of the aforementioned offences.
