1. Minutes of Previous Assembly:	The Minutes of the previous Assembly of Principals and Electors of The Parish of St Brelade held on 31 March 2026, were adopted as read, and signed, following a proposition by Deputy Montford Tadier which was seconded by Centenier Michel Bougeard with all in favour.

This nomination was seconded by Mr Peter Durham - Waite. The Connétable congratulated Mr Haywood and advised that the date to appear before the Royal Court of Jersey to take the Oath of Office would be Friday 1 May 2026.</p>
